Cancellations MUST be made 10 days prior to your arrival date VIA EMAIL ONLY for a full refund, No exceptions. Any Cancellation made less than 10 Days' notice will result in the forfeiture of the \$100 deposit or one night if made on a holiday /event weekend.

Check in is at 12:00pm, check out at 11:00am. Please inquire if you would like a late check out. Upon arrival please be sure to check in at the marina office to sign in and receive your welcome packet. Balance is due upon arrival via cash or credit card; no checks will be accepted. Four pool passes are included with each transient overnight reservation additional passes may be purchased.

Our pool is open from Father's Day weekend through Labor Day.

GENERAL WATER CLUB & MARINA RULES

1. No Swimming or diving shall be permitted from the docks, slips, floats, or within the basin.
2. Mattituck Creek is a No Wake Zone. All boater must comply with this law, especially around our docks.
3. Pets must be on a leash at all times. The pooper-scooper law applies to the marina.
4. Noise shall be kept to a minimum at all times so as not to disturb or inconvenience other persons using the marina, especially between the hours of 10:00 pm and 9:00 am.
5. Vehicles belonging to the boat owner, and anyone associated, shall be parked in the designated parking areas, to allow access by emergency vehicles. Any vehicle blocking emergency access or loading zones will be towed at the owner's expense.
6. All boats tied at our slips must use bow, stern, and spring lines. Those who do not will be responsible for any damage they cause.
7. The use of insufficient or worn dock lines is strictly forbidden and management may replace all such lines with suitable dock lines at their discretion, the cost of which shall be paid by the renter.
8. No person shall discharge oil, spirits, waste, flammable liquids or oily bilges from their vessel.
9. No smoking on the gas dock.
10. Any type of littering is prohibited. All refuse should be placed in the appropriate receptacles.
11. Trailers left on the property are subject to a storage fee. Trailers must be secured by the owner to prevent loss. Tongue locks or other devices to prevent theft must be installed. Trailers must also have the owner's name clearly and permanently marked on the tongue for easy identification. Lessor is not responsible for theft or damage to trailers.
12. Owners must maintain liability and casualty insurance at all times. If the contract with proof of insurance is not provided we will not be able to provide you dockage.
13. Strong's Water Club & Marina LLC and Strong's Marine Inlet LLC does not insure boats stored on land and is not liable for damage due to theft, fire or any collision that may occur.
14. Storage is at the sole risk of the owner and owner must maintain liability and casualty insurance.

POOL RULES AND REGULATIONS

1. Only pool-approved toys allowed in pool; no foreign objects allowed in pool.
2. No food or glass allowed in pool area.
3. Membership or guest pass must be presented for access to pool.
4. Membership passes are non-transferable. A \$20.00 fee will be charged for a replacement pass.
5. Marina reserves the right to limit number of guests.
6. All members and their guests must comply with posted rules and regulations.
7. Children under 16 years of age must be accompanied by and be under the constant supervision of an adult member.
8. Marina is not responsible for pool closure due to force majeure, vandalism, or mechanical failure beyond operator's control. No refunds will be issued.
9. Only Coast Guard approved life preservers are permitted as per Suffolk County Department of Health Services.
10. Infants and toddlers must wear plastic cover over diapers.
11. If pool is closed due to weather conditions, no refunds will be issued.
12. Parents are solely responsible for their children's conduct and behavior. Children may be asked to leave the pool area after three (3) warnings from the Lifeguard on duty.

I understand that swimming and boating can be hazardous activities. The undersigned hereby releases, waives, discharges, and covenants not to sue the owners, operators or members of Strong's Water Club & Marina, LLC and Strong's Marine Inlet LLC, Pace's Dockside, and any other owners and lessees on premise for any and all loss, damage, claim, or demands related to boating and/or swimming activities, whether caused by the negligence (excepting the willful or gross negligence) of the releases or otherwise.

I hereby agree to indemnify and save and hold harmless the releasees and each of them from any loss, liability, damage, or cost they may incur arising out of or related to boating or swimming activities, whether caused by the negligence (excepting the willful or gross negligence) of the releasees or otherwise.

I hereby assume full responsibility for any risk of bodily injury, death or property damage, whether caused by the negligence of releasees or otherwise. I accept and agree to the terms and conditions as provided in this contract.
